- Comply with the provisions of the rules and the instructions that are given by the technical staff .

## 3. - General provisions:

- The Guardian may contact by telephone and visit the participant, under the conditions referred to in paragraphs 14 and 15 of the Internal Summer camp Regulation;
- In case of withdrawal by the Participant, only the dropouts in writing within at least seventy-two hours (three days) before the start of the summer camp are to be eligible for the 75% refund of the registration fee (see Section 7 of the Rules of summer camp ) ;
- In case of cancellation of the summer camp by **Projecto Novas Descobertas**, the full amount of the registration fee will be refunded the (see point 8 of the Rules of Holiday Camp);
- Projecto Novas Descobertas** reserves the right to unilaterally terminate this AGREEMENT if the payment referred to in paragraph 1. - Subparagraph e) of this term of responsibility is not paid as agreed.
